# 12<sup>TH</sup> NATIONAL CONFERENCE OF HEALTH DELEGATE'S PROFILE

The health conferences - places for the exercise of Social Control - besides disseminating information and processes of implementation of health policies, they mobilize the organized society, congregating strengths around the proposals and struggle for the confrontation of the structural and conjunctural problems of the sector.

- Who are the delegates who had pointed out the direction lines concerning health policies in the 12th National Conference Health?
- Which are their main characteristics, their confidence in SUS and insertion in Social Control?

## SOCIO-DEMOGRAPHIC CHARACTERISTICS

- 53.4% are men and 46.6%, women;
- 49.9% are white; 46.7%, black; 2,4%, yellow and 0.4%, Indian.

66,1% of the delegates are 40 years old or more. This means that at the time when the health system was changing, through the Constitution of 1988, these delegates were 25 years or more.

#### **EDUCATION LEVEL**

- 39.9% have high school graduation;
- 47.6% are university graduated.
- · 20,3% are post- graduated.
- 14.3% have specialization, 4.5% Master Science and 1.5% PhD;
- 4.9% have completed basic education and
  3.8% incomplete basic education.

These results indicate the exclusion of the population with low education level from the social control process of health policies, even in the segment of users.

### **QUALIFICATION IN HEALTH**

- 58.3% of the delegates have qualification in health.
- 85.7% of these are workers, 83,8%
  Managers and 76,4% assistants
- 36.7% of the users have qualification in health.

These data suggest that the delegates who represent the segment of the users are also professional in health.

#### **USE OF HEALTH SERVICES**

- 64,6% of the delegates used SUS recently, while 34,5% have opted to private health services;
- 63.3% of the assistants and 56,5% of managers choose private health services, while 79,5% of the users and 61,0% of the workers used SUS;
- 51% of delegates have Health Insurance
- 49,9% of users with Health Insurance used SUS the last time they needed health services

The data make evident that the delegates of the 12<sup>th</sup> CNS, even engaged in the struggle for the SUS, use private health services over the national average, although using SUS once in a while

### PARTICIPATION IN PREVIOUS CONFERENCES

- 71% has participated at a National Health Conference for the first time;
- 83.5% did not participated at the 11th CNS;
- 86% did not participated at the 10 th CNS;
- 92.2% did not participated at the 9 th CNS;
- 93% did not participated at the 8 th CNS.
